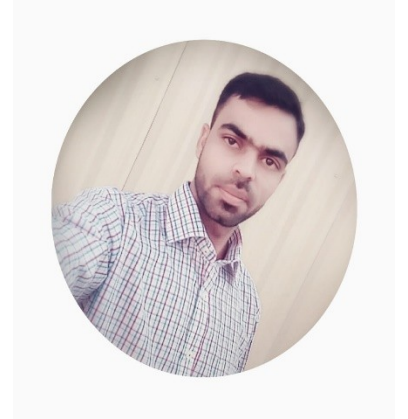

Pre-inspection using Dial micrometer and replica tape (for the blasted surface) DFT gauge (Electronic Type), WFT (Comb gauges), Temperature Gauge (Check for Humidity, Steel, Air and Dew point Temperature) and Issue an Internal RFI to QC in charge for Client Acceptance
